CALL FOR PROPOSALS

International Coordination of Research on Infectious Animal Diseases (ICRAD)

“Helminth infections and changing climate: tackling the challenges for animal health”

Deadline for submission of pre-proposals:

1 June 2023, 15:00 CEST (Berlin)

This document announces the third transnational call on infectious animal diseases within the framework of the International Coordination of Research on Infectious Animal Diseases (ICRAD) ERA-NET¹.

The overall objective of this research call is to increase understanding and preparedness for impending effects on animal health and livestock industry caused by spread of anthelmintic resistance and climate change.

Consortia must include a minimum of 3 partners from a minimum of 3 different countries, and a maximum of 8 partners. The consortium cannot include more than two partners from one country. Industry involvement is encouraged.

Applicants must respect eligibility rules of the call and the national/regional rules and regulations of their respective national/regional funding organisation as outlined in section 5 and Annex I of this document. In some cases, an additional application to the national/regional organisation is necessary. Applicants are strongly advised to contact their funding contact point.

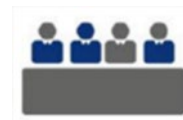

Objectives of the 3rd ICRAD Call

The 3rd ICRAD call aims to increase understanding and preparedness for impending effects of climate change and the spread of anthelmintic resistance on animal health and the livestock industry.

This call aims to fund research in three separate fields to achieve the following objectives:

- Improve understanding of anthelmintic resistance and develop intervention tools to prevent it.
- Better understand impacts of climate change on animal health.
- Develop new detection and prevention platforms.



3rd Call Thematic Background

- Resistant helminth populations are found in all grazing livestock species, and resistance has developed to all major classes of anthelmintic drug¹.
- Helminth infections cost the European livestock industry more than €1.8 billion per year in production losses and treatment costs².
- Changes in climatic patterns can affect disease incidence and vector behaviour whilst higher than average temperatures can cause significant stress to livestock systems.
- Projected global economic losses due to climatic impacts on livestock by the mid-21st century range from \$9.7 to \$12.6 billion³.

Development of the Scope - Evidence

We collated research priorities from the following documents:

- DISONTOOLS – Research gaps for improving disease control in animals
- BBSRC Veterinary Vaccinology Research and Innovation Survey Report: Gaps and Priorities (based on global consultation)
- ICRAD SRIA Survey Results
- STAR-IDAZ Animal Influenza Research Priorities

The main priorities listed in these documents were grouped and placed in an online survey which was sent to ICRAD partners, industrial partners, STAR-IDAZ members and other interested parties.



3rd Call Topics – Anthelmintic Resistance

Research Area 1: Research to improve understanding of anthelmintic resistance mechanisms, the impacts of anthelmintic resistance on livestock health, and development of tools to help diagnose, prevent, and manage it.

Potential areas of interest could be:

- Improving methods used for diagnosis and monitoring of helminth infections, including drug efficacy;
- Tests for detecting anthelmintic resistance against all anthelmintic classes in helminth species of importance;
- Pen-side tests and associated decision support tools that rapidly inform on levels of infestation and morbidity;
- Develop methods to quantify or map levels of anthelmintic resistance present in livestock herds;
- Understanding the biological response of helminths to changing climatic conditions and potential impacts on anthelmintic usage/ requirements;
- Improved knowledge of the immune mechanisms associated with natural, and vaccine induced protection from helminths; and
- Development of novel, and improvement of currently available helminth control strategies including anthelmintic vaccines.

3rd Call Topics – Impacts of Climate Change on Animal Health

Research Area 2: Research to increase understanding of the impacts of climate change and vector borne diseases on animal health, including development of tools to prevent, prepare and respond to animal health emergencies triggered by climate change.

Potential areas of interest could be:

- Epidemiological monitoring of changes to spatial and temporal distribution of animal disease resulting from climate change— including development of novel digital tools to visualise, collate and report this information;
- Modelling and forecasting of the impacts of climate change on the spread of infectious livestock disease - including how animal movement and implementation of control zones could influence this;
- Understanding changes to transmission and pathogenicity of animal disease resulting from climate change; and
- Understanding direct and indirect impacts of climate change, for example thermal stress, on susceptibility of livestock to disease.

3rd Call Topics – Vaccine and Diagnostic Technology Platforms

Research Area 3: Research to support the development of novel and improved vaccine and diagnostic tools and platforms and research to assess the utility and efficacy of existing technology platforms.

a. Vaccine Technology Platforms Robust and flexible vaccine platform technologies, fit for multiple, and rapidly changeable vaccine targets, can reduce the technical and regulatory time for vaccines against emerging pathogens.

b. Diagnostic Technology Platforms Novel and point of care diagnostic platforms are needed to accurately detect disease presence in animals. Although reagents are available to develop diagnostics in many animal species, these are not always practical in the field or effective at detecting the presence or exposure to pathogens.

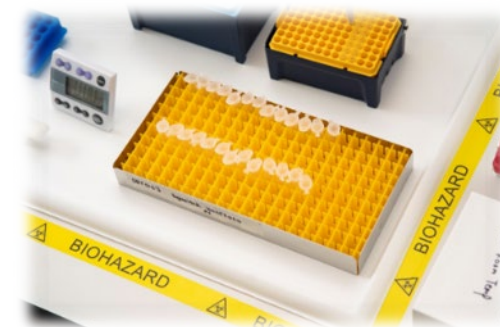


Exclusions & Industry Involvement

The research funded through this call is to improve health of livestock and the focus of each research proposal should be on animal health/disease. Research that mainly focuses on the below **are not in the scope of the call**:

- Improving human health
- Companion animals
- Food-borne pathogens
- Animal welfare
- Environmental/climatic modelling
- Antimicrobial resistance
- Ectoparasites

A collaborative approach between academic and industry sectors is encouraged for this call. Especially for projects which aim to develop vaccine and technology platforms as part of Research Area 3.

Eligibility



III. Conditions and requirements

General Eligibility

- The application must be written in **English**
- Pre-proposals must be submitted by **1st of June 2023** (15:00 CEST Berlin) using the ERA-NET ICRAD submission website (www.submission-icrad.eu/call3).
- Max. duration of a project: **36 months**
- Researchers can contribute to more than one research proposal submitted to this call, provided there is no double funding of the same work or cost item. In case researchers participate in two or more research proposals, they are obliged to respect the national/ regional rules related to double funding. In the section “Partners” (via Partner Login) under “Tasks within the project” they must name the proposals, in which they are involved and explain clearly how their work within the respective proposals differs. Participation as project coordinator is only possible in one research proposal.
- Projects must follow the rules outlined under “consortium structure”.

III. Conditions and requirements

General Eligibility - Consortium Structure

Partner: Asking for funding

Associated Partner: Not asking for funding, Letter of Commitment necessary!

- Min. of **three partners (asking for funding)** from a **min. of three different countries.**
- **Maximum 8 per Proposal!**
- **Not more than two partners from 1 Country!**
- Applicants from non-participating countries or non-eligible applicants can participate at their own costs (**associated partners**)
- Associated partners will **not** count **towards the maximum or minimum** numbers.
- Associated Partners can only be partners, not coordinator of a proposal.
- The budget of non-funded partners shall not exceed 30% of the requested total transnational project budget.
- Total funding per country must not exceed 60 % of the total funding budget of the proposal in order to achieve balanced partnerships and ensure that responsibility and risks are shared.

Be really careful with your project consortium composition and better ask the call secretariat to be sure! If rules are not fulfilled your project will be ineligible → No Funding!

III. Conditions and requirements

General Eligibility - Consortium Structure

Examples

3 Partners from Germany, 1 from Estonia, + 2 Associated Partners	No	Less than three countries with full partners involved!

3 Partners from 3 Countries	Yes	Minimum number of full partners fulfilled
4 Partners from 3 Countries, + 3 Associated Partners	Yes	All eligibility rules fulfilled
8 partners from 5 Countries, 0 Associated Partners, not more than two from one country	Yes	All eligibility rules fulfilled

III. Conditions and requirements

National Eligibility

National eligibility criteria as described in the National Regulations:

- **READ** the national ANNEX!
- Which Research Area can be funded (Not all Funders fund all Research Areas!)?
- Budget per project (Some Funders have budget limitations per project or per partner!)
- Who can apply for funding (research institutions, SMEs, differs from funder to funder)
- Whether a submission of a national application is requested

Consult your National Contact Point!

Make sure every Partner in your proposal contacts the National contact point!

In case one partner of a project consortium is not eligible, the Call Board may reject the entire proposal.

III. Conditions and requirements

Call Budget (in M€)

- Overall Call Budget: ~ 5.65 Mill €
- Different Budget per Country/Funder
- Please be aware of different maximum budget per project partner → It is also possible to stay well below the max. amount!
- Please discuss your proposed budget with your national contact point and make sure your project partners do so too.
- Total eligible budget per country must not exceed 60 % of the total eligible project budget in order to achieve balanced partnerships and ensure that responsibility and risks are shared. → **make sure the budget in your project is well distributed, according to the tasks the partners have to fulfil**

All information must be entered to the submission tool.

III. Conditions and requirements

Project monitoring, meetings and reporting

- Partners from each funded project are expected to organise regular project meetings
- Possible ICRAD Meetings, Coordinator obliged to participate
- Coordinators will most likely be required to submit a mid-term and a final report to the funders about the results of their transnational project (in addition to reporting required by the national funding bodies)





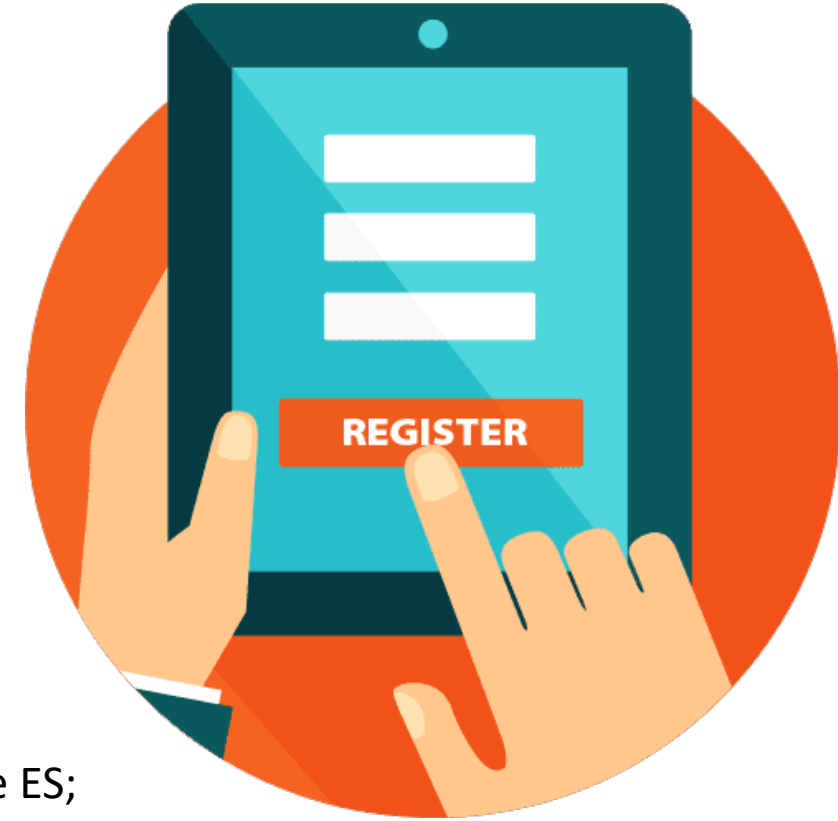
- **2 Step procedure through Online Evaluation Tool:**

Step 1: Evaluation of Pre-proposals

Step 2: Evaluation of Full proposals

- **Platform registration**

1. Expert receives personalized **login data** to the **online evaluation tool** from the ES;
2. **Upload signed Confidentiality Agreement** to get access to the core data of the projects (abstract, consortium, title);
3. Based on the core data, experts will be asked to declare whether they have a **CoI** with assigned proposals.



V. Evaluation: Evaluation criteria of pre-proposals

Excellence

- a) Scientific quality of the proposal.
- b) Relevance of the project regarding the addressed research area and objectives of the call.

Impact

- a) Potential impact of the expected results for future animal and public health.
- b) Added value of transnational collaboration: gathering a critical mass of biological material, sharing of resources (models, databases, etc.), harmonization of data, sharing of specific know-how and/or innovative technologies, etc.
- c) Potential for fostering a longer-term international network of researchers.

Quality and efficiency of the implementation

- a) Coherence and effectiveness of the work plan (for full proposals: including appropriateness of the allocation of tasks, resources and timeframe).
- b) Complementarity of the participants in the consortium.



V. Evaluation: Evaluation criteria of full proposals - 1

Excellence

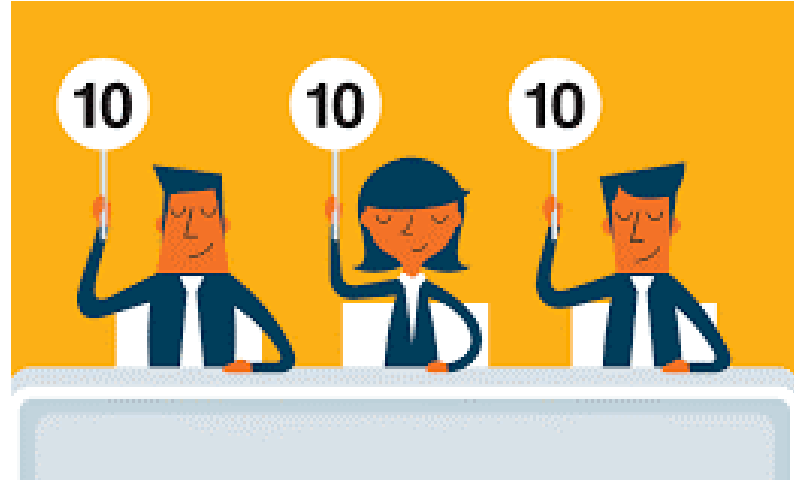

d) **Effectiveness** of the proposed **measures** to exploit and disseminate the project results (including management of IPR), to communicate the project, and to manage research data where relevant.

e) **Involvement of private partners** (SME and/or industry, if available (when appropriate/applicable)).

f) Possible impact of age, gender and socio-economic status (when appropriate/applicable).

g) Education and training of young scientists (when appropriate/applicable).



V. Evaluation: Evaluation criteria of full proposals - 2

Quality and efficiency of the implementation

Same as for pre-proposals

- c) Appropriateness of the management structures and procedures, including risk and innovation management.
- d) Sustainability of research infrastructures initiated by the project.
- e) Budget and cost-effectiveness of the project (appropriate distribution of resources in relation to project activities, partners' responsibilities and timeframe).

Scores for the three evaluation criteria will have equal weight



V. Evaluation: Evaluation procedure

Peer review:

- Each pre-proposal is reviewed by at least 3 evaluators from the ISEC
- The assignment of the pre-proposals to the experts is done by ES with support of the ISEC Chair and Co-Chair according to the relevant expertise of the reviewers
- Pre-proposal **evaluation** is held **remotely via the online evaluation tool**.
- For **each pre-proposal**, one ISEC member is assigned as **rapporteur**. The **rapporteur** drafts a **summary report** for each proposal reflecting the individual evaluation reports (strengths & weaknesses).



V. Evaluation: Decision-making

As a result of the evaluation, a ranking list of the full proposals recommended for funding will be established.

Based on the ranking list, the funders will take the final decision for national/regional funding, following general guiding principles :

- Fund as many high-quality projects as possible;
- Balanced geographical representation (e.g. for proposals with the same ranking).

The outcomes of the funding recommendations will be communicated by the Call Secretariat to the project coordinators, who shall inform their respective partners
